5. Committee Reports: Trustee Wentworth updated the Board regarding the recent Finance Committee meeting. He stated that budget trends are good, expenses are as expected, and discussed one-time expenses that will be made in the 2017-2018 fiscal year. These one-time expenses include replacing all classroom projectors with new Promethean panels and updated technology.

Trustee Dei Rossi reviewed items discussed at the recent Governance Committee meeting. These items included the renewed accreditation of eight years awarded by WASC Senior College and University Commission (WSCUC), terms of office for current board members, and the TCSJ 2018 commencement speaker.

The Academic Affairs Committee meeting was canceled due to lack of new items. No update was given.

Governing Board Workshop: Dr. Carnahan gave a brief synopsis of the activities and topics from the recent Teachers College of San Joaquin Governing Board Workshop. She said that all but two trustees were able to attend. Others attending the workshop were Jamie Mousalimas, San Joaquin County Superintendent of Schools, Jane Steinkamp, Assistant Superintendent, Educational Services, and Terrell Martinez, Division Director, Business Services. The event included team building activities, professional development, and in-depth discussions regarding the budget and strategic plan. Dr. Carnahan expressed the feedback from everyone was very positive.

- 7. Memorandum of Understanding: Chair Tony Gutierrez updated the Board regarding a Memorandum of Understanding (MOU) between San Joaquin County Office of Education (SJCOE) and TCSJ. He explained the reasoning why the MOU is not needed; The TCSJ By-laws state the relationship between SJCOE and TCSJ and works in place of an MOU.
- 8. 2018 Commencement Speaker Update: Dr. Dei Rossi updated the Board regarding the 2018 commencement speaker. Dei Rossi informed the Board that a speaker has been selected and contacted but has not accepted the invitation as of yet. More details will be provided at a later date.
